Background

Korin Korin Balit-Djak is the Victorian government's strategic directions for Aboriginal health, wellbeing and safety. Improving eye health outcomes can be defined under *Strategic Direction 5.2.4: Manage Illness better through culturally responsive, connected supports and care.*

Overview

The Victorian Department of Health and Human Services is offering ten one-off grants of up to \$500 to assist individuals to attend the National Indigenous Eye Health Conference, 'Close the Gap for Vision by 2020: Striving Together'.

Eligibility

- Applicants must be employees or clients of an organisation providing eye health services for Aboriginal and Torres Strait Islander people in the state of Victoria.
- Eligible organisations include Aboriginal community controlled health organisations, hospitals, community health services, primary care partnerships and non-government organisations funded by the Victorian DHHS providing health services to Aboriginal people.

How you can apply for a grant
