Aim of Activity *

To improve the health outcomes of people with chronic conditions in rural areas by providing access to integrated care.

Description of Activity *

A redesigned service model for chronic conditions care across western Victoria will commence from 1 October 2023. The new service model – referred to as Regional Care Partnerships (RCP) - Chronic Conditions, is a partnership-led service delivery model that brings together local health agencies to deliver integrated, outcomes focused services for people living with, or at risk of a chronic condition/s that are responsive to needs in local contexts.

RCP aligns to the extensive service redesign process undertaken throughout 2021 – 2022 as part of WVPHN's commitment to adopt a place based-commissioning strategy. It involved several steps including scan of current evaluations, literature and policy documents, co-design with stakeholders and health consumers and market soundings with current and potential service providers to redesign mental health (MH), alcohol and other drugs (AOD) and chronic conditions programs.

The procurement process undertaken throughout late 2022 – early 2023 identified a lead agency within each of the four WVPHN subregions (Ballarat Goldfields, Geelong Otway, Great South Coast and Wimmera Grampians) representing formal partnerships to deliver RCP - Chronic Conditions for a three year period (July 2023 – June 2026), including the transition period.

Transition from the previous model, Chronic Conditions Model of Care (CCMC), into RCP – Chronic Conditions will occur over July-September 2023 and includes the transition of all current clients and waitlists from the previous CCMC program to the RCP model. A detailed transition plan and issues management strategy are being implemented to mitigate identified risks.

Commissioned organisations within each sub-region will provide services that focus on a person-centred approach to care, treatment, and management. The service is flexible to facilitate and support evidence-based treatment, operating across the spectrum of care and tailored to individual needs. Within the model, clients will move between their usual primary care provider, commissioned suppliers and other service providers for chronic disease treatment interventions tailored to their needs and preferences. Clients move through various stages of care including:

- referral to additional support (Regional Care Partnerships: Chronic Conditions) for chronic condition management that is supported by clear referral pathways and eligibility criteria that supports early intervention.
- active navigation that connects clients to other services and/or community-based programs, supported by collaborative partnerships and defined referral pathways into other services which may include connection to other relevant WVPHN programs including alcohol and other drugs, mental health, care finder, cancer shared care, palliative care, family violence and/or community transport.
- self-management/ maintenance supported by formal skills training such as health coaching and evidence-based digital health tools/ initiatives such as GoShare, blood pressure monitors, pedometers.
- timely discharge back to the client's usual primary care provider for continued support and self-management support as required, and to ensure commissioned services are directed to those most in need (supported by clear discharge criteria and communication back to primary care providers about the client's care within the program and any continued support that may be required).

This activity responds to the chronic conditions' priority identified in the WVPHN Needs Assessment providing services in rural areas to increase access and reduce the impact of chronic conditions. This activity involves the delivery of services within a system that improves the health and consequently health outcomes for people experiencing or at risk of developing chronic conditions. WVPHN will work with each commissioned organisation to ensure:

- Service delivery targets are met;
- People with or at risk of developing chronic conditions in rural areas have access to integrated care; and
- Health outcomes of people with or at risk of developing chronic conditions are improving.

Each of the models must also focus on delivering optimal service delivery by developing and enhancing:

- Practitioners' knowledge base and quality of care, while educating patients about their condition;
- Appropriate clinical governance to provide best care;
- Clinical information systems to provide optimal service delivery that supports patients to achieve their own health goals and assists practitioners to manage patient's care more effectively.

Activities include:

- * Commissioning organisations to continue to deliver evidence based chronic conditions treatment services for a period of three years (to 30 June 2026)
- * Referral pathway development and implementation
- * WVPHN is committed to ongoing monitoring and evaluation of RCP and will fund a comprehensive evaluation to track progress and performance and provide opportunities for quality improvements to be made within the service model across the three years and prior to contract extensions.

Partnerships underpin service integration by bringing together the strength and expertise of individual service providers, fostering collaboration and coordination. WVPHN will also continue to liaise with ACCHOs during the establishment and implementation of the RCP- chronic conditions model and support a self-determination approach to service delivery.

- * Extend the capacity of Aboriginal Community Controlled Health Organisations (ACCHOs) to refine a stepped continuum of care young people most at risk to the onset or relapse of severe and complex illnesses. These services are to be culturally relevant and embedded within the Social and Emotional Wellbeing (SEWB) framework for Aboriginal peoples.
- * Combining culturally appropriate service delivery using best evidenced treatments aim to reduce the duration of untreated illness and potential disruption to young aboriginal peoples leading contributing lives within their communities.
- * Further, they are intended to integrate opportunistic general health screening and preventative interventions, aligned with the equally well consensus, to reduce the risk developing chronic diseases later in life that shorten the life expectancy of people that experience mental illness. They will build pathways between acute and disability service sectors based on best practice principles that support timely access and smooth transition between sectors based on the need of young people.
- * Continue to facilitate discussions and forums with service providers to enhance referral pathways, implement shared cared arrangements and build relationships with general practice and other healthcare providers.

There are eight (8) ACCHOs across western Victoria. A co-design project with the Aboriginal and Torres Strait Islander community has commenced to help refine the services delivered over time. In 2019 ACCOs were invited to tender for funding to deliver these services across the region. Four ACCOs were successful in this tender process and are contracted to deliver services to cover the whole of the WVPHN region. Each ACCHO was invited to propose how the services would be established to meet key deliverables and delivered in a culturally safe and appropriate way. Several guidelines have underpinned the strategic planning and development of these youth severe services including:

- * The Fifth national Mental Health and Suicide Prevention plan;
- * National Aboriginal and Torres Strait Islander Health Plan 2021-2031
- * Working Together; Aboriginal and Torres Strait Islander mental Health and Wellbeing Principles and Practice;

Description of Activity *

The Community Transport Service for Rural Victoria Project will provide a sustainable service that enables eligible clients (Healthcare, Pension or DVA card holders or people over the age of 65 years) free transport to medical, dental, allied health, specialist appointments, and formal well-being activities within a designated catchment. The model will encourage collaboration with local government, health services and service providers and will focus on providing sustainable transport to health care within areas of most need throughout regional Victoria.

The key objective of the Community Transport Service for Rural Victoria Project is to establish eight community transport hubs, including expansion of the existing hub in Heathcote, with a centrally located coordinator/s to manage day-to-day functions utilising purpose-built scheduling software.

WVPHN will work in partnership with Murray PHN (MPHN) and Gippsland PHN (GPHN) to deliver this project. It is planned that there will be two new community transport hubs established in the MPHN region, plus the expansion of the existing Heathcote community transport hub, three new community transport hubs established in the GPHN region and two new community transport hubs established in the WVPHN region.

Through collaborative partnerships with Murray PHN and Gippsland PHN, WVPHN will commission the Royal Flying Doctor Service (RFDS) to deliver the community transport service which aims to improve access to health services for rural and regional Victorians by overcoming known transport barriers.

Through the analysis of relevant data and in collaboration with stakeholders, MPHN, GPHN and WVPHN will determine the area/location of transport hubs within their catchment to ensure it meets the needs of their region.
