The Western Victoria Movement Disorder Better Care pilot will enhance the overall health and life outcomes of those living with movement disorders in rural and remote areas of western Victoria by achieving the following objectives:

- Embedding a Movement Disorder Nurse in each of the four identified health services
- Building specialist knowledge of movement disorders and clinical capacity within existing local multidisciplinary health service teams
- Supporting a comprehensive coordinated approach to managing complex movement disorders
- Building the capability of people living with complex movement disorders to better manage their condition and increase their access to referral pathways, treatments, and therapies.

Description of Activity *

The Western Region Movement Disorder Better Care pilot will deliver accessible, specialist care for people living with Movement Disorders, including Parkinson's disease in rural and remote western Victoria where a prevalence cluster has been identified.

Working in collaboration with regional and rural health service partners, the pilot will place Movement Disorder nurses in the following areas:

Horsham - Wimmera Health Care,

Warracknabeal - North West Health Care, Stawell - Grampians Community Health Warrnambool - South West Health.

The following activities will be undertaken:

- The Western Region Better Care pilot Movement Disorder Nurses will provide clinical care and care coordination, working in partnership with GP's and multidisciplinary professionals to provide interdisciplinary care where the collaboration of health care professionals aims to address complex health problems and enhance health outcomes for people living with Movement Disorders.
- The Movement Disorder Nurses will be supported in their capacity to support health services through the provision of targeted education and training provided by the following: Post Graduate Australian College of Nursing, Parkinson's Victoria, Annual MDS membership and UPDRS Certificate.
- Regional health services will also receive ongoing support from Parkinson's Victoria's multidisciplinary health team; a highly skilled team of movement disorder and progressive neurological health care professionals, able to provide clinical supervision, peer networks, education and information product for Parkinson's disease and other movement disorders.
- In conjunction with Parkinson's Victoria, the Movement Disorder Nurses will create a movement disorders community of practice, using the online community tool "ECHO" (Enhanced Community Health Outcomes). The development of an online community of practice will contribute to building a sustainable model of care in regional Victoria.
- Western Victoria Primary Health Network will undertake to build a data set that can assist in more comprehensively understanding the prevalence of movement disorders through the analysis of available hospital and health service data, as well as looking at prescription data to build a higher level of understanding. This will aid the development of better supports into the future and contribute a new data set to the Western Victoria Primary Health Network Needs Assessment

The high prevalence of the movement disorder Parkinson's disease has been identified as an emerging health priority for Western Victoria PHN. Parkinson's disease and other related neurodegenerative and neurodevelopmental disorders, hyperkinetic movement disorders, and abnormalities in muscle tone and motor control are known as movement disorders and include the following conditions: Essential Tremor, Dystonia, Ataxia, Huntington's disease, Multiple System Atrophy and Progressive Supra Nuclear Palsy.

Aim of Activity *

The Wound Management pilot will build capacity and skills in primary care to improve wound management patient outcomes in rural areas of Wimmera Grampians by achieving the following objectives centered around the quadruple aim.

- * To improve the skills, capacity and confidence of the primary care workforce in delivering evidence based wound care management, allowing clinicians to work to their upper scope of practice (Improved provider experience).
- * To test in general practice process for workflow that identifies an at risk patient cohort for early detection, intervention and education to prevent the development of a chronic wound. Increased health literacy will reduce the cost of care for chronic wound by decreasing preventable hospital admissions (Population Health and Cost).
- * Support general practice to optimise utilisation of the current MBS and other funding options to support sustainable improvements to wound care services (Cost).
- * Improve both health care professional and community awareness of wound care services enabling care closer to home, decreasing travel costs and wait times as well as increase quality of life and working capacity due to improved wound management in primary care (Improved patient experience).
- * To improve service and system integration for general practice, other primary care providers and health services

Description of Activity *

* Project initiation – establish project plan in consultation with Wounds Australia, including governance framework and recruitment of project officer.

- * Mapping existing services identifying gaps and barriers, undertaking training needs assessment and building on existing Western Victoria PHN resources such as HealthPathways, GoShare, education events, tools and resources.
- * Recruiting and supporting four general practices with grants to participate in a 12-month quality improvement activity or to establish a Nurse-Led clinic for wound management. Other opportunities to be created to support building the local workforce skills and capacity which would include scholarships for primary health care practitioners to undertake studies in wound care management. Scholarships will target opportunities for Aboriginal Health Care Practitioners. This phase would include education events that facilitate service and system integration with participation from general practices including ACCHOs, health services, allied health and home care services. The approach to education will include train the trainer identifying champions building sustainability beyond the life of project.
- * Reviewing project outcomes/learnings and reinforcing the project with resources for sustainability of benefits beyond the life of the program (to include project evaluation). The Quadruple Aim which underpins Western Victoria PHN's performance framework would be the lens for evaluation of the project.
